SPORTS CENTER 2023 - POOL WILL NOT BE OPEN

DURING THE PAST SEVERAL MONTHS THE BOARD HAS REVIEWED AND DISCUSSED SEVERAL OPTIONS ABOUT THE REQUIRED REPAIRS AND THE OPERATING COSTS OF THE POOL.

AS A RESULT OF THESE DISCUSSIONS IT HAS BECOME EVIDENT THAT UNLESS THE POOL IS RE-PLASTERED THE ASSOCIATION CANNOT GUARANTEE THE WATER QUALITY, AS WELL AS THE SAFETY OF POOL OPERATIONS DUE TO THE CONSTANT DISINTEGRATION OF THE PLASTER AND THE BUILDUP OF PLASTER ON THE POOL FLOOR. THIS BUILDUP OF THE PLASTER ALSO CAUSES DAMAGES TO THE FILTRATION EQUIPMENT. AT THE CURRENT TIME FUNDS SUFFICIENT FOR THE COST OF THE RE-PLASTER ARE NOT AVAILABLE AND BECAUSE OF THIS

THE POOL WILL BE CLOSED FOR THE SUMMER OF 2023

WITH FUNDS TO BE SET ASIDE FOR THE RE-PLASTER AND ADDITIONAL REQUIRED REPAIRS WITH THE INTENT TO RE-OPEN THE POOL IN THE SUMMER OF 2024
